PDG Schedule for 2024 Edition

Please note:

- Meeting all deadlines is essential for the timely publication of the 2024 Review of Particle Physics.
- Papers published through January 9, 2024 will be included via literature searches. Additional published papers may be included at the discretion of the overseer until February 14, 2024. Adding new data or papers after February 14, 2024 requires group leader approval that will only be granted in special cases.
- Updates of review articles for the 2024 edition of the *Review* must be completed in 2023 according to the schedule below. In 2024 only minimal updates to synchronize numbers and figures with the 2024 Listings will be possible. Rare exceptions for special cases require approval well in advance.

Oct 11, 2023	All referee comments addressed, final reviews (incl. Booklet versions) signed off to editor

Minimal review updates to synchronize numbers and figures with 2024 Listings

Mar 13, 2024	Authors submit minimal updates to overseers. Extension to Apr 5 (Apr 17 for overseer) possible upon request for reviews that depend on winter conferences or averaging groups.
	Overseers check minimal updates, sign final reviews (incl. Booklet version) off to editor

1st encoding cycle (covering ~8 months of publications)

Aug 15, 2023	Early, partial release of literature search by editor
Sep 8, 2023	Editor releases literature search to encoders (literature search up to Sep 1 completed by Sep 5)
Oct 18, 2023	Encoders complete entering encodings in PdgWorkspace, sign off encodings to overseer
Nov 15, 2023	Overseers sign off encodings, verification starts
Dec 13, 2023	Verification and corresponding changes by overseer completed; final encodings with editor

2^{nd} encoding cycle (covering ~4 months of publications)

- Jan 10, 2024 Literature search up to Jan 9 completed
- Jan 12, 2024 Editor releases literature search to encoders
- Feb 7, 2024 Encoders complete entering encodings in PdgWorkspace, sign off encodings to overseer
- Feb 28, 2024 Overseers sign off encodings, verification starts, any fits from external groups requested
- Apr 5, 2024 Overseers finish corrections from verification, add external fits, update Conservation Laws
- Apr 17, 2024 Overseers complete checking/correcting Summary Tables. 2024 Listings completely done
